ACTION Receives Grant Funding from Massachusetts Clean Energy Center

January 29, 2013 (Fall River, MA) - ACTION, the Association of Cleantech Incubators of New England, today announced that the Massachusetts Clean Energy Center (MassCEC) has awarded \$90,000 in funding to support the launch of ACTIONPass, a new program designed to drive clean energy business activity to Massachusetts and the Northeast region through a diverse network of cleantech incubators and to gather data regarding Massachusetts clean energy incubators and their member companies.

Cleantech entrepreneurs, regardless of geographic location, may engage with and contribute to the already robust cleantech ecosystem in Massachusetts and the Northeast through ACTIONPass, ACTION's new membership level. The program provides an affordable entry point for cleantech startups not ready for full incubation to access meeting space and programs within the growing network of ACTION incubators.
